sources are well managed. But we need to continue to manage our water carefully, and also ensure that historically disadvantaged South Africans, particularly women, can benefit from the use of water."

Our project has the following objectives:

- Assess the need for capacity building and empowerment.
- Develop training materials.
- Conduct empowerment workshops.
- Facilitate engagement with local WUAs (Clanwilliam, Citrusdal and Sandveld).
- Engage with the pilot compulsory licensing process taking place in the Jan Dissels River catchment
- Monitor and evaluate the effect of these engagements.
- Provide access to further education and training in project planning and management, financial management and marketing.
- Facilitate "farmer to farmer" extension.

Ockhuis explains: "Emerging farmers, like any farmer, needs water. Under apartheid, we were denied access to water. We now need to participate effectively in the Water Allocation Reform process in order to put right the wrongs of the past. Now we will help our members to apply for water licenses, not just for projects aimed at eradicating poverty and increasing food security, but also for establishing large scale commercial farming enterprises."

In the long term, we aim to:

- Ensure the sustainable development of the emerging farmers in the Cederberg Municipal Area;
- Ensure the forum becomes an effective mouthpiece for emerging farmer associations, especially with regard to land and water allocation reform.
